2009 MEMBERSHIP AGREEMENT

Members will be subject to all Club Rules, Regulations and to the following;

1. Starting Times. Timber Ridge Golf Club members may obtain starting times three weeks in advance. Management reserves the right to evoke special considerations for events and out-of-town guests. Starting times are required for all play and may be obtained in the golf shop.
2. Members will be responsible for damage to any property of the Club, caused by member or member's family, guests or invitees.
3. Membership fees are not refundable and membership privileges are not assignable, unless approved by the Club.
4. Membership privileges may be revoked by the Club for violation of the Club's rules and regulations.
5. Use of the Club facilities is at the sole risk of the member, and member waives any claim for loss or damage to member's property in connection with member's use of the facilities.
6. Member agrees to hold the Club harmless for any and all injuries incurred while on the Club property.
7. Annual Membership expires on December 31, 2008 following application approval unless otherwise extended by club management, or terminated for violation of the Club's rules and regulations. Any renewal is subject to approval by the Club at its sole discretion.
8. All facilities, equipment, hours, prices, services, rules, regulations and policies of the Club are subject to change at the sole discretion of the Club.
9. Member acknowledges that membership is not an investment in the Club. Annual Dues are pre-paid user fees, and do not create or convey a legal equitable property interest of any kind, nature, right or description whatsoever in either the Club or the Club facilities.
10. A Member's use is limited to the facilities at Timber Ridge Golf Club and does not extend to any other properties and / or businesses.
11. Member acknowledges that the entire property or a portion thereof known as Timber Ridge Golf Club may be closed from time to time at the discretion of the Club, for special events and routine or necessary maintenance and repairs. Such events or routine maintenance and repairs will not cause the Member to receive any additional consideration or reimbursement for the lost time and opportunity.
12. All players are required to register in the golf shop and pay applicable fees prior to any play. Play without registering with the golf shop is prohibited even if your membership includes all fees.
13. Proper golf attire is expected for all players. Cut-off jeans, swimsuits, or tank tops are not acceptable. Men must have shirts with sleeves at all times.
14. No more than four players may play together at any time. The General Manager or Head Golf Professional reserves the right to adjust this number on those rare occasions when circumstances may allow.
15. All players shall observe proper golf etiquette including repair of all ball marks, raking of bunkers and replacing of divots.
16. Range Pass Members will be limited to unlimited range use to the days of their golf membership benefit.
17. Range Pass Members will have unlimited usage of range balls from May 1, 2009 to October 15, 2009.



DISCIPLINARY ACTION

The General Manager (GM) and/or Head Golf Professional (HGP) shall have power to reprimand, suspend, expel, or otherwise discipline any Member from committing any violation of the Rules and Regulations; or for conduct unbecoming a Member; or for any offense against the best interests of the Club; or for other good and sufficient cause determined by the GM and/or HGP. The GM and/or HGP shall have the power to reprimand, suspend, expel, or otherwise discipline any Member for nonpayment of fees and accounts.

12. Member acknowledges that Timber Ridge Golf Club is sole owner of the Club and all related facilities with the sole right to operate the Club and such facilities. These rights include but are not limited to:

- a. The right to change or discontinue operation of the Club facilities.
 - b. The right to exercise any and all other rights of ownership including the right of sale to others.
- Membership in the Club will be governed by these terms, conditions, and the Club rules and regulations. The Club at its sole discretion will determine such terms, conditions, rules and regulations. Ownership of a home that may border the facility confers no membership rights upon the owner of such home, nor any right to make application for membership, nor any right to make use of the golf course or other related facilities. Fees charged for the use of the golf course, clubhouse and membership in the Club are subject to the sole discretion of the Club and are subject to change. No representation is made regarding the type, availability or number of memberships that the Club may offer from time to time.

I HEREBY CERTIFY AND REPRESENT THAT I AM OVER THE AGE OF 18 YEARS, HAVE READ AND FULLY UNDERSTAND ALL TERMS OF THE MEMBERSHIP CONTRACT AND I INTEND TO BE LEGALLY BOUND AGREE TO ABIDE BY ALL TERMS. THIS AGREEMENT REPRESENTS THE ENTIRE AGREEMENT AND SUPERSEDES ANY PRIOR AGREEMENT OR UNDERSTANDING CONCERNING THE SUBJECT MATTER HEREOF.
